2. Must confirm City and/or State Right-of-Way.
3. Must ensure that any electrical work is performed by a licensed electrician and inspected by the City for compliance with City codes.
4. Must obtain a permit for any re-design or re-configuration of an existing sign.
5. Must comply with any other regulations required by the City.
6. Must confirm if project is in CBD(C-4).
7. Must confirm if project is in the Historic District. If so, must obtain approval from the Historic Preservation Commission prior to sign placement.

ALSO, IT IS HEREBY UNDERSTOOD AND AGREED THAT THE WORK IS TO BE DONE ACCORDING TO SPECIFICATIONS AND REQUIREMENTS AS SET FORTH IN THE ORDINANCES OF THE CITY OF LAUREL, MISSISSIPPI, GOVERNING SUCH WORK AND IT IS UNDERSTOOD AND AGREED THAT SHOULD THE CONTRACTOR AND/OR OWNER FAIL OR REFUSE TO COMPLY WITH THE SAID ORDINANCES OF SAID CITY OF LAUREL, THEN SUCH PERMIT SHALL IMMEDIATELY BECOME NULL AND VOID. SUCH PERMIT IS GIVEN WITH THE UNDERSTANDING THAT THE CONTRACTOR AND/OR OWNER WILL SAVE THE CITY OF LAUREL HARMLESS FROM ANY ACCIDENT OR INJURY WHICH MAY BE CAUSED BY HIS WORK OR NEGLIGENCE.

SIGN PERMIT NULLIFICATION

The permit fee for a sign valued at Five Hundred Dollars (\$500.00) or less shall be one-half (1/2) of the minimum fee for a building permit. The permit fee for all other signs shall be based on the building permit fee schedule. However, a sign permit shall become null and void if the work for which the permit was issued has not been completed within a period of six (6) months after the date of the permit; OR the sign varies in any respect from the approved design or location. A new sign application with fee is required in the event of any nullification.

PERMIT IS VALID FOR 6 MONTHS FROM DATE OF ISSUANCE.

I ALSO AKNOWLEDGE THAT I AM RESPONSIBLE FOR ALL NECESSARY CLEAN-UP AND DISPOSAL ON JOB-SITE WHEN PROJECT IS COMPLETE.

BY MY SIGNATURE, I HEREBY CERTIFY THAT I HAVE READ AND EXAMINED THIS DOCUMENT AND KNOW THE SAME TO BE TRUE AND CORRECT. I FURTHER AGREE THAT ALL WORK WILL COMPLY WITH CITY STANDARDS AND ORDINANCES IN ACCORDANCE WITH THE GOVERNING JURSDICTION OF THE CITY OF LAUREL.
